**Part 1: Annual Summary Report for Prelicensing courses offered in-person, via synchronous distance delivery (aka, “live-online”), and via blended delivery.**

For each Education Provider, the following data is provided:

- **# Enrolled:** The number of students who enrolled in Prelicensing courses during the period.
- **% Passed:** The percentage of students who successfully completed Prelicensing courses during the period.
- **% Failed:** The percentage of students who met the attendance requirement but did not pass the end-of-course exam in Prelicensing courses during the period.
- **% Dropped Out:** The percentage of students who did not meet the attendance requirement in Prelicensing courses during the period.

## Part 2: Annual Summary Report for distance (self-paced, online) Prelicensing courses.

For each Education Provider, the following data is provided:

- **# Enrolled:** The number of students who enrolled in Prelicensing courses during the period.
- **# Passed:** The number\* of students who successfully completed Prelicensing courses during the period.
- **# Timed Out:** The number\* of students who did not complete all units and assessments in Prelicensing courses during the period.
- **# Failed:** The number\* of students who completed all course content but did not pass the end-of-course exam in Prelicensing courses during the period.

\*Note that actual student numbers, rather than percentages, are provided. This is due to the differences between Summary Reports for distance courses vs. other course delivery modes. Each month, Education Providers that offer distance Prelicensing courses submit Summary Reports that show the number of students who enrolled in Prelicensing courses during the previous month, as well as numbers of students who completed courses during the previous month, either successfully or unsuccessfully. However, because students are provided extended access to courses, possibly as long as 180 days, the total number of enrolled students does not necessarily correlate to the total number of students who completed courses during the same period. In other words, students who enrolled in courses during the final weeks or months of this 12-month period may not have completed those courses by the end of the 12-month period.
