5 ~~[(a) Schools and course sponsors shall cancel or suspend all in-person courses until April 30, 2020.]~~

6 ~~[(b)](a) Until June 10, 2020, schools and course sponsors may offer synchronous distance learning for continuing~~
7 ~~education courses.]~~ Until June 30, 2020, schools and course sponsors may offer synchronous distance-learning for
8 prelicensing and postlicensing courses. “Synchronous distance-learning” means the instructor and students are
9 separated only by distance and not time, allowing for real-time monitoring of student participation.

10 ~~[(e)](b)~~ Schools shall allow students to make-up prelicensing and postlicensing course hours by attending another
11 course of the same type offered by the same school. The make-up hours attended by the student shall be for the same
12 content that the student missed.

13 ~~[(d)](c)~~ An applicant who is unable to take the licensing examination within 180 days pursuant to 21 NCAC 58A
14 .0401 due to illness or the testing service locations being closed shall make a written request using the Commission’s
15 website. The Commission shall grant each applicant an extension of 90 days to take the licensing examination.

16 ~~[(e)](d)~~ A broker requiring an extension of time to complete the 12-hour Broker-in-Charge Course pursuant to 21
17 NCAC 58A .0110(e) and .1712(b)(5) shall make a written request using the Commission’s website prior to the
18 licensee’s original 120 day deadline. The Commission shall grant each broker an extension of 90 days to complete the
19 12-hour Broker-in-Charge Course.

20 ~~[(f)](e)~~ The Commission shall grant all brokers an extension of time of 90 days to complete postlicensing or continuing
21 education courses.

22 ~~[(g)](f)~~ The Commission shall waive the prelicensing and postlicensing course examination requirements of [21
23 NCAC 58H .0210(a)(2), .0210(b)(2) and .0210(e).] 21 NCAC 58H .0207(a)(2), .0207(b)(2), and .0207(c).
